### 1 Privacy Collection Statement for tenants

Real estate industry laws, regulations or codes of conduct in certain Australian States and Territories may require us to verify your identity in certain circumstances.

We will collect your personal information and the occupants you list on your application from you where possible, but we may also collect your information from third parties, such as your employer, your real estate agent, from the operators of any residential tenancy databases services or similar rental history checking services and from other third parties (including referees that you have provided).

We may disclose your personal information and the occupants you list on your application to our employees, related bodies corporate, contractors and agents to answer your queries and provide our services to you. We may also disclose your personal information to any relocation agents that you or your employer engage, to any real estate agents who have suitable properties available for rental and to operators of residential tenancy databases or similar services. Where necessary, we will also disclose your personal information to government bodies and regulatory authorities (where required or authorised by law) and to our service providers, suppliers and other third parties with whom we have commercial relationships. In some circumstances, we will disclose your personal information to our related bodies corporate, IT service providers or third party suppliers located overseas and also to your referees, employer and your relocation agent, if they are located overseas. These parties may be located in United Kingdom, India, and also in the country or countries in which your referees, employer or your relocation agent operates.
